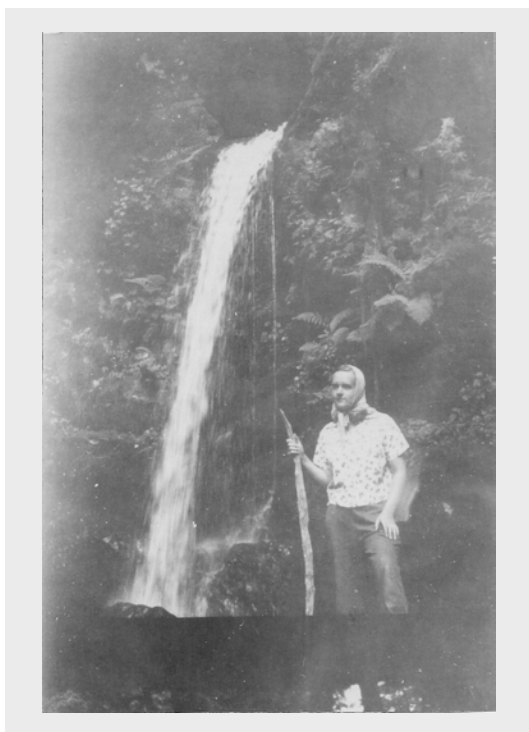
### Welcome to Spring in Arch Cape

## Arch Cape Community Center Planning Continues

The AC-FCB Community Club is exploring the acquisition of the old fire station for use as a community and recreation center. The Cannon Beach Rural Fire Protection District is building a new substation at the north end of Arch Cape, next to Castle Rock Estates. That leaves the old substation empty. A group of community members are exploring the acquisition of the building to upgrade it for community activities.

Committee members include: Cathy & Richard Donofrio, Debra Birkby, Nadia Gardner, Mike Manzulli, Doug U'ren, Barbara & Jim Shaw, Philip Simmons, Charles Dice. New members are welcome.

Since the last Tunnel Echoes, the committee has developed a community survey to gauge community support and collect ideas for activities. 450 surveys were sent via mail and email. Landowners and residents encouraged to return surveys as soon as possible. Also, we are developing a business plan, including a capital and operating budget. This will help us determine whether a center is feasible and allow us to apply for grants if we move forward.

The fire substation may go up for sale as soon as June. So, we may need to get help purchasing it from an individual or group of citizens and then raise funds to purchase it from them. Let us know if you might be open to such support.

## Commissioner's Corner



Due to continued individual community efforts, recommendations from the "Options Committee" (formed to address Arch Cape concerns) and those involved in Tsunami Emergency Preparedness the consideration of using of short term rental tax revenues for needs in our geographic area, is being addressed for the first time in the proposed Clatsop County Budget. All changes will require Board approval.

The Board of Commissioners has appointed new members to the Southwest Coastal Citizen Advisory/ Design Review Committee. Joining Chair John Mersereau, existing members Tod Lundy and Richard D'Onofrio are Michael Manzulli, Virginia Birkby, Dan Seifer and Linda Gaylord Eyerman. Staff facilitator Julia Nevan Decker continues to work with the group reviewing building projects in the Arch Cape area.

County leaders, health department staff and health care providers have been meeting to prepare, understand and implement the State of Oregon's planned changes for Medicare and Medicaid users in Clatsop County. Once the choice is made for a Coordinated Care Organization provider, known as a

CCO, the transition to take over services for the Oregon Health Plan clients will begin. The State and County goal for Oregonians is the "Triple Aim" focused on  
Improving lifelong health  
Increasing quality, reliability & availability of care  
Lowering or containing the cost of care, to make it affordable for all

### **Joanne Cornelius: Resident of Falcon Cove and raiser of chickens by the Sea**

I met Joanne at her home in Falcon Cove Beach. She has an amazing property with a tranquil garden, which she was tending to, overlooking the surf on the south end of Falcon Cove. Joanne has lived here since 1972. She moved here with her husband, her children were finishing high school. Her husband, a linguist, produced both books and videos teaching the english language was able to work from their home. Their only requirement was proximity to an international airport. After looking at properties in the Gearhart, the home at the South end of Falcon Cove was an easy choice.

Joanne was born and raised in La Grande. The daughter of a Rancher, son of a Rancher who in turn was a son of a Rancher. She grew up on a working ranch, raising livestock and growing vegetables and grains.

After moving to Falcon Cove, Joanne and her husband ran their business, producing books and videos to be used to teach english in several countries including Japan, Korea and China. At one point, in the mid 1980's, then ran a "full scale post production facility for broad cast quality film" out of their garage. Mind you, this was in the 80's. Long before the PC and Macintosh made it possible for teenagers to edit movies on their laptops and cellphones. They developed this business into a full service post production company that was able to do the finishing work on all types of commercials. Remember the California Raisin commercials (I do...they were not that long ago)...right there is Joanne's Garage.

Joanne has recently spent quite a lot of energy in caring for others very close to her through the end of life. In 2005, Joanne's husband was diagnosed with Alzheimer's Disease. For those who may not know, Alzheimer's Disease is the most common form of dementia. There is no cure and it worsens as

it progresses to death. She cared for him at home, for the most part on her own. Every day. He passed away last June. During this same timeframe she helped provide care for her mother, who passed away at the age of 103.

Joanne raises chickens. Not roosters (that would not be neighborly), She is on her second batch. The first batch ran free and somewhat wild around her yard. I . This new batch, she got as chicks, are being raised indoors now (warmer, and out of the sight of the local hawks). She has an amazing chicken coup, picture an Long A Frame, chicken size, with a picture window at the bottom and the roost up top. And look at the view!

Joanne has been active in the community, serving many years as a member of the water board.





## North Coast Land Conservancy Speaks at May 19 Potluck

North Coast Land Conservancy (NCLC) no longer meets in a Gearhart living room, and they now have four staff people to handle the tide of opportunities for

conservation and stewardship that arise daily in this unique coastal landscape. Yet North Coast Land Conservancy remains firmly rooted in the coastal communities that we serve and in the common ground we share.

All are a part of Oregon's coastal landscape: local residents and weekend vacationers, farmers, small businesses, developers, corporations, schools, municipalities and private landowners along with salmon, eagles, elk and other wildlife. All depend upon trees and other plants, soil and water, and we humans need roads, buildings and bridges. We are all active participants in the complex community of the coastal region we live in, and we all share the responsibility of its stewardship now and in to the future.

At North Coast Land Conservancy, they focus stewardship actions with a mission that holds

conservation at its core. From their earliest project – helping facilitate the expansion of Saddle Mountain State Park to provide a healthy buffer for old growth forest along Fox Creek – to their most recent conservation acquisition, working with a local timber company to protect a rare 33-acre riverine forest along a continuous mile of the Necanicum River, they have been fortunate to share our 25-year journey with a great number of outstanding volunteers, organizations, community partners and businesses who have all contributed to their success.

At the Saturday, May 19th AC-FCB community potluck (6 p.m.), join Executive Director, Katie Voelke for a look back at the remarkable path that has led NCLC to where they are now standing, and together enjoy discussion as we all look ahead to the goal: a fully functioning coastal landscape where healthy communities of people, plants and wildlife all thrive.

## Notes from the Fire Station:

The plans for the new Arch Cape Fire Station have been completed. 7 Contractors submitted the Pre-Qualification paperwork and showed up for a mandatory “walk-thru” at the site on 25 April.

We currently estimate that construction would begin within 30 days and would be completed in about 3 to 4 months. The new Fire Station will have three engine

bays, a command/office room with radio and emergency communications equipment, a large meeting room, a kitchen, and two bathrooms as well as a large storage space for Emergency equipment and supplies.

With the addition of the conference room and kitchen, the new Fire Station will accommodate the Arch Cape Falcon Cove Beach Community Club meetings as well other local organizations that have been using the existing Arch Cape Fire Station for their meetings. The new Station will provide and ADA

approved parking space and access. The site has also been approved by LifeFlight for emergency helicopter landings.

Upon completion, the new Arch Cape Fire Station will house our existing Fire Engine (3226) and we currently have three fire-fighters in the Arch Cape/Falcon Cove Beach area who would be able to operate this engine to provide fast response to our local emergency service calls.
